



AP 6760 BICYCLES, SKATEBOARDS, ROLLER BLADES, AND SIMILAR ROLLER DEVICES

Vehicle Code Sections 231, 21200-21210, 21113, 21453, and 22450

Definitions

The term “bicycle” shall mean “a device upon which any person may ride, propelled by human power through a belt, chain, or gears, and having one or more wheels” as defined by the Vehicle Code Section 231, as may be subsequently revised. “Bicycles” may also be electric or motor-driven.

The term “roller device” shall mean roller skates, roller blades, skateboards, coasters, scooters, toy vehicles, or any similar device upon which a person may be propelled by human power. “Roller devices” may also be electric or motor-driven and include self-balancing two-wheeled vehicles.

The term “District property” shall mean all property owned by the Santa Barbara Community College District, leased by the District, and rented by the District, including parking lots, driveways, roadways, sidewalks, walkways, structures, including classrooms and non-classroom areas, and all improvements thereon. District property also includes any drainage channel, ditch, culvert, or other improved storm water control system that is situated, in whole or in part, upon District property.

Roller Device Regulations

No person shall use a roller device upon any District property under any circumstances.

Bicycle Regulations

Bicycles may be used on District property subject to the conditions provided herein.

Vehicle Code Sections 21200-21210 are incorporated into this administrative procedure by reference and are applicable to all persons on District property. These sections include, but are not limited to, the following regulations:

- On a roadway with a bike lane, bicyclists traveling slower than traffic in the same direction at that time must use the bike lane except when making a left turn, passing, avoiding hazardous conditions, or approaching a place where a right turn is authorized. (Vehicle Code Section 21208)
- Bicyclists on a roadway traveling slower than the normal speed of traffic moving in the same direction at that time must ride as close as practicable to the right hand side of the road, except when passing, preparing for a left turn, avoiding unsafe conditions, or if the lane is too narrow. (Vehicle Code Section 21202)



Cyclists must obey all traffic lights, traffic signs, and other regulatory signs and pavement markings. (Vehicle Code Sections 21453 and 22450)

Bicycles may only be ridden on designated bike routes/lanes or on roadways. Bicycles may not be ridden on any sidewalks, in any dismount areas, in campus buildings, over shrubbery, or on grass.

Bicycles may only be parked or stored in the bicycle racks provided. Bicycles stored illegally will be impounded.

Cyclists must exercise due care and use reasonable caution at all times while operating a bicycle. Cyclists shall not ride at an unsafe speed or operate the bicycle in a manner that may cause personal injury or property damage.

Campus Security Enforcement

1. Santa Barbara Community College District Currently Enrolled Students

- First Violation: A warning will be issued and the student's name will be placed in a Master Name File.
- Second Violation: The individual will be referred for student discipline.

2. Non-Students

- A warning will be issued and the name will be placed in a Master Name File.

Santa Barbara Police Department (SBPD) Enforcement

The SBPD shall enforce this procedure and related policy when on District property. If warranted, a citation will be issued pursuant to Vehicle Code Section 21113g and BP 6760 Bicycles, Skateboards, Roller Blades, and Similar Roller Devices.
